Dear Member,

Well, I have to say that it's nice to be back in sunny England! I say this because my husband and I have been away for the last couple of weeks in the USA, visiting our daughter. Whilst we were obviously delighted to see her and her family, for most of our stay in the area it was one of the coldest Junes for many years and we were reduced to wearing our emergency clothing, which I became heartily sick of!

Turning back now to Mole Valley, the Hearings being conducted by the Planning Inspector into the Draft Local Plan are now under way, with Stage 1 having been conducted and finished during June. Stage 2 happens in the last week of September and Stage 3 in two weeks during October .The Inspector has confirmed that the LRA can present their views on the proposed residential development sites for Leatherhead at one of the Stage 3 Hearings .

Progress has also been made with the development of Claire/James house, on the River-front. The Council has confirmed ME Developments as its development partner for the project, which will comprise 35 flats (some affordable) and a ground floor café and amenity space. ME has recently submitted a "reserved matters application" in respect of issues not settled within the original planning application /consent process.

KFC has now been officially asked to be more considerate in their use of the free parking bays outside their new restaurant in Church Street, as both customers and other businesses nearby have been dismayed at their heavy use by the delivery scooters serving KFC.

LRA member, Hilary Porter, informs me that help is available to those who find themselves somewhat cut off from society by their inability to make full use of mobile phones and computers. On a more positive note, Mole Valley has been awarded approx. £1m from the Government's "UK Shared Prosperity Fund " to be spent over the next 3 years. Our Council will be managing the fund, but are liaising with District stakeholders, such as the LRA, as to suggestions for beneficiaries and other matters of detail.

In connection with some S.C.C. and M.V. meetings I get asked to, could I have your suggestions as to what small improvements you would like to see in Leatherhead? For instance, I would like our planters to look more permanent, i.e. in stone or wood. Or are there any verges which to your eyes look unloved and could do with planting and maintenance?
